**ATTACHMENT TO ARTICLES OF ORGANIZATION
OF FARMING NOW!, LLC**

Article V: Purposes:

A. Farming Now!, LLC (the “Company”) is organized to be a nonprofit limited liability company under Kentucky Revised Statutes.

B. The Company is organized exclusively for charitable, educational and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the “Code”). In furtherance of its foregoing purposes, the Company educates students on agriculture and technology through hands-on experience coupled with classroom learning to allow students to develop STEM skills while also producing fresh produce for their community.

C. Upon the dissolution of the Company, the assets of the Company shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Code to organizations exempt from Federal income tax under Section 501(c)(3) of the Code or to the federal government or a state or local government for a public purpose. Any assets so not disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the Company is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

D. No part of the net earnings of the Company shall inure to the benefit of, or be distributable to its managers, officers or other private persons, except that the Company shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth above. No substantial part of the activities of the Company shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Company shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles, the Company shall not carry on any other activities not permitted to be carried on (a) by a corporation or entity exempt from Federal income tax under Section 501(c)(3) of the Code, or (b) a nonprofit limited liability company under Kentucky law.
