## ARTICLE I Name of Limited Liability Company

The status of a person as a member, manager, employee, or agent of the limited liability company shall not subject the person to personal liability for the acts or omissions, including any negligence, wrongful act, or actionable misconduct, of any other member, manager, agent, or employee of the limited liability company.

#### ARTICLE IX Indemnification

The limited liability company shall indemnify a member or manager for judgments, settlements, penalties, fines, or expenses incurred in a proceeding to which a person is a party because the person is or was a member or manager.

#### **ARTICLE X Effective Date**

These Articles of Organization shall be effective upon filing.
