The undersigned person, serving as the organizer, pursuant to KRS 275, hereby executes and files the following Articles of Organization under the Kentucky Limited Liability Company Act.

Article 1. Name

The name of the limited liability company shall be CW Ventures, LLC (the "Company").

Article 2. Initial Registered Office and Initial Registered Agent

The initial registered office of the Company shall be located at 4500 Bowling Blvd., STE 100, Louisville KY 40207, and the initial registered agent at such office shall be Melissa A. Arnold.

Article 3. Initial Principal Office

The mailing address of the initial principal office of the Company shall be located at 4500 Bowling Blvd., STE 100, Louisville KY 40207.

Article 4. Statement of Management

The Company shall be managed by a manager or managers.

Article 5. Restrictions

The members may enter into an operating agreement, buy-sell agreement, or other agreement limiting the rights of members to assign, pledge, or transfer all or a portion of their interests in the Company.

Article 6. Classes of Members

There shall be two classes of members in the Company: Class A and Class B. Class A Interests may be owned only by Managers. If any person who owns a Class A Interest ceases to be a Manager, such person's Class A Interest shall be converted into a Class B Interest. Class A members and Class B members shall have certain relative rights, powers, or duties, including voting rights, as expressed in the operating agreement.

The members may enter into an operating agreement providing for the future creation, in the manner provided in the operating agreement, of additional classes or groups of members having certain relative rights, powers, or duties, including voting rights, expressed either in the operating agreement or at the time the classes or groups are created, including rights, powers, or duties senior to those of at least one existing class or group of members.

Article 7. Classes of Manager

There shall be one class of manager in the Company. The members may enter into an operating agreement providing for the future creation, in the manner provided in the operating agreement, of additional classes or groups of managers having certain

relative rights, powers, or duties, including voting/management rights, expressed either in the operating agreement or at the time the classes or groups are created, including rights, powers, or duties senior, or junior, to those of at least one existing class or group of managers.

The undersigned hereby certifies that the foregoing constitutes the Articles of Organization of CW Ventures, LLC.
