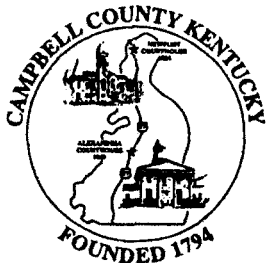

Dear Campbell County Property Owner or Resident:

As Campbell County continues to grow, the existing address system (which includes rural route and box numbers, many streets with similar names, street names with numbers, etc.) is no longer adequate for police, fire and ambulance services to find you quickly in the event of an emergency. In response to this problem we are implementing a new addressing system for the unincorporated portions of the county and some cities. The new addressing system affects your property address. Your property address will be modified as follows:

<u>Old Property Address</u>	<u>NEW PROPERTY ADDRESS</u>
156-C Fender Road Melbourne, KY 41059	3054 Fender Road Melbourne, KY 41059
Reference Code:	x16-23-Fender Road

This new address becomes effective on September 1, 2003. You can assist in speeding emergency response teams by posting this new address on both sides of your roadside mailbox. If you do not have a roadside mailbox, please post your new address numbers at your driveway entrance or on the front of your home or business. These numbers should be at least three inches tall so that they can be seen clearly from the street.

We realize that there is some inconvenience associated with this change. To minimize this inconvenience, we have been working with the post office, utility companies, and other agencies that provide services to you. We have given your new address to these agencies. Of course, this brief list does not cover all your personal and business contacts. The post office has informed us that mail will continue to be sent to your old address for six months. However, we ask that you notify your family, friends, and others of your new address as soon as possible. Change of address cards are available at your local post office.

We also note that this change may impact some of your personal documents (mortgages, deeds, etc.). We recommend that you consult with your attorney, accountant, or other personal advisor on the best way to update this information to meet your individual needs.
