ARTICLES OF ORGANIZATION OF GULF LAND & SEISMIC, L.L.C.

ARTICLE I

The name of the limited liability company is : GULF LAND & SEISMIC, L.L.C.

ARTICLE II

The Company shall exist from the date of filing of these Articles of Organization with the Secretary of State of Louisiana until the occurrence of the first to occur of any of the following:

(1) the unanimous consent of its members to dissolve; (2) entry of a decree of judicial dissolution under Louisiana revised Statutes 12:1335; or (3) the death, interdiction, withdrawal, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in this company, unless within ninety (90) days after such event, this company is continued by the unanimous written consent of the remaining members or as otherwise provided in the Operating Agreement or any other agreement by, between or among the members, and, if Membership is reduced to one, the admission of one or more members.

ARTICLE III

The purpose of the Company is to engage in any lawful act or activity for which limited liability companies may be organized under the Louisiana Limited Liability Company Law, as now in effect or hereafter amended (the "Act"). This limited liability company shall enjoy every power and capacity authorized, granted or conferred by the law either now in force or hereinafter enacted.

ARTICLE IV

The management of the Company shall be vested in co-managers who shall have continuing exclusive authority to make management decisions necessary to the conduct of the business for which the Company is formed. No member of the Company shall have the authority to bind the Company unless such member is also a manager of the Company and except as provided in the Company's Operating Agreement. The first managers of this company shall be Shawn Richard, Ashley Gremillion and Karen Monceaux. In addition any one of these co-managers shall be the certifying officer upon whose certification of authority or membership any one may rely.

ARTICLE V

An operating agreement may be executed by the members of this company and it may set forth provisions for the affairs of this company.

This limited liability company will indemnify the managers of this limited liability company and its member(s) to the fullest extent of the law, provided that the manager and/or member acted in good faith and who reasonably believed that his conduct was in the best interest of the limited liability company.


