ARTICLES OF INCORPORTATION

OF

The undersigned incorporator, being a natural person of full age of majority, and desiring to form a professional corporate entity under Minnesota Statutes, Chapters 319A and 302A, hereby \checkmark adopts the following Articles of Incorporation:

Article I

The name of this corporation shall be: Robichaud & Nepp, P.A.

Article II

The location and address of this corporation's registered office in this state shall be 402 Towle Building, 330 Second Avenue South, Minneapolis, MN 55401.

Article III

In accordance with Minnesota Statutes Sections 319A.04 and 481.02 Subd.2, the purpose of this corporation is to render professional legal services through attorneys licensed to practice law in the State of Minnesota.

Article IV

The aggregate number of shares which this corporation shall have the authority to issue is 1,000,000 shares each with no par value, which shares shall be designated common stock. No share shall be issued until it has been paid for, and thereafter it shall be non-assessable.

Article V

Shareholders have no rights of cumulative voting.

Article VI

In accordance with Minnesota Statutes Section 319A.11, this corporation may issue shares only to those individuals licensed to practice law in the State of Minnesota.

Article IX

The number of directors of the corporation shall be fixed and may be altered from time to time as may be provided in the Bylaws. In the case of any increase in the number of directors, the additional directors may be elected by the directors as shall be provided in the Bylaws.

Article X

A director of the corporation shall not be personally liable to the corporation or its shareholders for monetary damages for breach of fiduciary duty as a director, except for (i) liability based on a breach of the duty of loyalty to the corporation or the shareholders; (ii) liability for acts or omissions not in good faith or that involve intentional misconduct or a knowing violation of law; (iii) liability based on the payment of an improper dividend or an improper repurchase of the corporations's stock under Section 559 of the Minnesota Business Corporation or to (Minnesota Statutes, Chap. 302A) or on violations of federal or state securities laws; (iv) liability for any transaction from which the director derived an improper personal benefit; or (v) liability for any act or omission occurring prior to the date this Article IX becomes effective.
