ARTICLES OF ORGANIZATION

OF

68 RENTAL, LLC

The undersigned, ADAM CHRISTOPHER LILEY, does hereby execute these Articles of Organization for the purpose of forming, and does hereby form, a limited liability company under the laws of the Commonwealth of Kentucky in accordance with the following provisions.

ARTICLE I: NAME

The name of the limited liability company is 68 RENTAL, LLC.

ARTICLE II: INITIAL PRINCIPAL OFFICE

ARTICLE III: INITIAL REGISTERED OFFICE AND REGISTERED AGENT

There shall be no stated date at which this Limited Liability Company shall dissolve. As such, it shall be perpetual as to duration unless dissolved by act or operation of law, or acts or omissions of its member(s) as stated herein or in their operating agreement(s).


