**ARTICLES OF ORGANIZATION
OF

KNOW ALL MEN BY THESE PRESENTS:

That, the undersigned, does hereby declare and affirm the intent and purpose of forming a professional limited liability company under the laws of the Commonwealth of Kentucky.

ARTICLE I

NAME

The limited liability company shall, to the fullest extent permitted by, and in accordance with the provisions of KRS 275 of the Kentucky Revised Statutes, and otherwise as permitted by law, indemnify each member of the limited liability company against expenses (including attorney's fees), judgments, taxes, fines, and amounts paid in settlement, incurred by him connection with defending any threatened, pending or completed action, suit, or proceeding (including attorney's fees), whether civil, criminal, administrative, or investigative. The indemnification provided for by this Article shall not be deemed exclusive of any other rights to which members of the limited liability company may be entitled under any statute, agreement or action by members of the limited liability company, or otherwise, and shall continue as to a person who has ceased to be a member of the limited liability company, and shall inure to the benefit of the heirs, executors and administrators of each person.
