

**ARTICLES OF ORGANIZATION****OF****Orange Beach Condos, LLC**

The undersigned person desiring to form a Kentucky limited liability company (hereinafter referred to as the "Company") pursuant to the provisions of the Kentucky Limited Liability Company Act, KRS 275, executes the following Articles of Organization:

**ARTICLE I – Name**

The name of the company is **Orange Beach Condos, LLC**.

**ARTICLE II – Registered Office**

The initial Registered Office of the Company at which required records of the Company will be kept is: 4924 Merton Square Louisville, KY 40241 and the initial Registered Agent located at the Registered Office is Sue Ehret.

**ARTICLE III – Principal Office**

The initial Principal Office of the Company is: 4924 Merton Square Louisville, KY 40241.

**ARTICLE IV – Members**

The Company shall initially have, and continue to have, at least two members.

**ARTICLE V – Management**

The management of the limited liability company is reserved to the managers, to be exercised in accordance with the operating agreement of the limited liability company.

**ARTICLE VI – Commencement Date**

The date upon which the Company is effective is the date of filing of these articles of Organization with the Kentucky Secretary of State

**ARTICLE VII**

The duration of the Limited Liability Company shall be perpetual, save and until its dissolution in accord with the Limited Liability Company Act and the operating agreement of the limited liability company.

ARTICLE VIII – Limited Liability

Except as otherwise provided by Kentucky law, no member, manager, agent or employee of the Company shall be personally liable for the debts, obligations, or liabilities of the Company whether arising in contract, tort or otherwise, or for the acts or omissions of any other member, manager, agent or employee of the Company

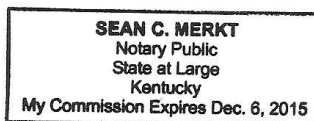
