ARTICLES OF ORGANIZATION

NSB FILMS, LLC

The undersigned, for the purpose of forming a limited liability company, as defined in Chapter 275 of the Kentucky Revised Statutes, on this 9th day of March, 2015, execute these articles of organization, and do hereby form a limited liability company in accordance with the following provisions:

NAME OF LIMITED LIABILITY COMPANY

The name of the limited liability company shall be NSB Films, LLC.

PRINCIPAL OFFICE

The principal office of the company in the Commonwealth of Kentucky shall be The Anchor Building, 2509 Portland Avenue, Louisville, KY 40202.

MEMBERSHIP

The company shall initially have two members.

MANAGEMENT

Pursuant to the terms of the operating agreement, the managing member shall manage the affairs of the company.

DURATION

The duration of the company shall be perpetual; subject to the duration set out in the operating agreement and/or dissolution pursuant to its operating agreement or by operation of law.

REGISTERED AGENT AND AGENT OFFICE


The name of the company's registered agent is Robert Johnston, and the street address of the office of the company's registered agent shall be 459 Swing Lane, Louisville, KY 40207.




CONSENT OF INITIAL REGISTERED AGENT
