**ARTICLE 11****Purpose**

The purpose of the LLC is exclusively for charitable, religious and educational, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the internal revenue code, or the corresponding section of any future federal tax code and herein stated as follows:

This LLC is being formed with the purpose of providing a safe space for Christian based religious worship for the local community, charitable works to serve and meet the needs of the local community and to educate the community in the word of God (the bible) as well as educating them on how good moral values are a key part of a flourishing community.

**ARTICLE 12****Prohibited Activities**

No part of the net earnings of the LLC shall inure to the benefit of, or be distributable to its members or other private persons, except that the LLC shall be authorized and empowered to pay reasonable compensation for services rendered.

No substantial part of the activities of the LLC shall be the carrying on of propaganda, or

otherwise attempting to influence legislation, and the LLC shall not participate in (including the publishing or distribution of statements) any political campaign in opposition to any candidate for public office. Notwithstanding any other articles, this LLC shall not, except to an insubstantial degree, engage in or exercise any powers that are not in furtherance of the purposes of the LLC.

#### Distributions Upon Dissolution
