**FILING INSTRUCTIONS
CANCELLATION OF CERTIFICATE OF LIMITED PARTNERSHIP**

NAME

Use the exact name of the business entity as registered on file with the Office of the Secretary of State.

DATE OF FILING

State the date that the limited partnership registered to transact business in Kentucky.

WHO MAY SIGN

The document must be signed by all general partners.

PRINCIPAL OFFICE ADDRESS

The principal office is the office (in or out of this state) so designated in writing with the Office of the Secretary of State where the principal designated office of the business entity is located. This address is where all correspondence from the Office of the Secretary of State (See Document Delivery) will be mailed.

EFFECTIVE DATE AND TIME

The document will be effective on the date and time of filing.

DOCUMENT DELIVERY

A file stamped postcard will be sent to the principal office address. If the applicant wishes for the document to be sent to an alternate address other than the principal office, a request must be submitted in writing affirming that request.
