## ARTICLES OF ORGANIZATION

of

### REST AND RENEWAL ENTERPRISES III, LLC

COMMONWEALTH OF KENTUCKY

JEFFERSON COUNTY

The undersigned, a person over the age of 18, for the purpose of forming a limited liability company under the Kentucky Revised Statutes 14A and 275, does hereby make, sign, adopt and acknowledge these Articles of Organization of Rest and Renewal Enterprises III, LLC.

#### Article 1

The name of this limited liability company is "Rest and Renewal Enterprises III, LLC."

#### Article 2

This limited liability company is formed for the purpose of engaging in any lawful activity for which limited liability companies may be formed under the Kentucky Revised Statutes.

#### Article 3

This limited liability company will be managed by its members. Limitations on the authority of the members to bind the limited liability company are contained in a written operating agreement. No member will be liable for the debts, obligations, or liabilities of this limited liability company.

#### Article 4

The duration of this limited liability company is perpetual.

#### Article 5

The operating agreement and all amendments to it will be in writing. In the event of a conflict between the articles of organization and the operating agreement, the articles of organization will govern.

### **Article 10**

Rest and Renewal Enterprises III, LLC shall have the power to expel a member, the conditions of which are contained in a written operating agreement.

### **Article 11**

Rest and Renewal Enterprises III, LLC shall have preemptive rights to make contributions or to make a contribution allowance agreement specifying future contributions of a certain amount before the LLC may accept new contributions from other persons or to make contribution allowance agreements with other persons.

**Article 12**

Rest and Renewal Enterprise III, LLC may establish more than one class of membership interests.

**Article 13**

Kim Stevens Trull, individually, is designated as the person to execute instruments transferring real property in the name of Rest and Renewal Enterprises III, LLC. This authority is subject to the limitations set forth in the written operating agreement.
