ARTICLES OF ORGANIZATION

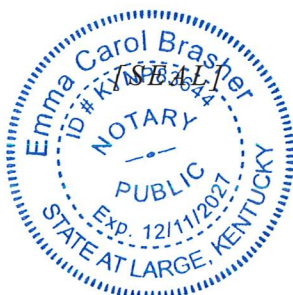


