The undersigned incorporators execute these Articles of Incorporation pursuant to the provision of the Nonprofit Corporation Act, KRS 273.161 *et seq.*, of this state, the undersigned incorporators, who are individuals 18 years of age or older, hereby adopt the following Articles of Incorporation in accordance with the following provisions:

ARTICLE I: NAME

The name of the corporation is Read Ready Kentucky, Inc. Business may be conducted as Read Ready Kentucky.

ARTICLE II: DURATION

Read Ready Kentucky will operate perpetually.

ARTICLE III: PURPOSE AND POWERS

Read Ready Kentucky is a non-profit corporation and shall operate exclusively for educational and charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future Federal tax code. This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Purpose One: Read Ready Kentucky is a state-wide literacy initiative. Our goal is to equip students with the power to change the world through reading.

ARTICLE IV: DIRECTORS

The business and affairs of Read Ready Kentucky shall be governed by a board of directors. The 6 members of the initial board of directors shall serve until the first annual election of directors and until their successors are elected and qualify. 


TO APPOINTMENT AS REGISTERED AGENT
