ARTICLES OF INCORPORATION

Pursuant to §273.161 et seq. of the laws of Kentucky, the undersigned majority are citizens of the United States and residents of the state of Kentucky, do hereby submit these Articles of Incorporation for the purpose of forming a nonprofit corporation. The effective date of incorporation shall be upon filing with the Secretary of State.

ARTICLE I. <u>NAME</u>

The name of this nonprofit corporation shall be Allen County Schools Parent Boosters, Inc. The business of the corporation shall be conducted under the name as selected.

ARTICLE II DURATION

The period of duration of the corporation is perpetual.

ARTICLE III **PURPOSE**

The Allen County Schools Parent Boosters, Inc. is a nonprofit volunteer organization composed of parents, staff and other interested parties who objective is to enrich the Allen County schools as well as the community. Our mission is to raise funds to enhance and expand our educational programs, support the students, their teachers, and the administration, in order to allow the students at the Allen County Schools to achieve their full potential. While the Allen County Schools Parent Boosters, Inc. primarily exists to assist our schools with financial support, the Allen County Schools Parent Boosters, Inc. also strives to promote good citizenship, high Allen County-Scottsville Parent Boosters, Inc.

ideals of character and academic achievement. Through these characteristics, the Allen County Schools Parent Boosters, Inc. recognizes the importance of education and the important role parents and the community play in educating every child. The corporation is organized and will be operated exclusively for charitable and educational purposes within the meaning of 501(c)(3) of the Internal Revenue Code. (All references to sections in these Articles refer to the Internal Revenue Code of 1986 as amended or to comparable sections of subsequent internal revenue laws.) In pursuance of these purposes the Corporation shall do all things necessary, proper and consistent with securing and maintaining tax exempt status under section 501(c)(3).

ARTICLE IV MEMBERSHIP

This corporation shall be comprised of members whose rights and qualifications determined in the manner set forth in the Bylaws.

ARTICLE V NONPROFIT NATURE

Allen County Schools Parent Boosters, Inc. is a nonprofit corporation. No part of the net earnings of the corporation shall inure to the benefit of or be distributed to any director, employee or other individual, partnership, estate, trust or corporation having a personal or private interest in the corporation. Compensation for services actually rendered and reimbursement for expenses actually incurred in attending to the affairs of this corporation shall be limited to reasonable amounts. No activities of the corporation shall include the carrying on of propaganda or otherwise attempting to influence legislation. Further, this corporation shall not intervene in (including the publishing or distributing of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of this Allen County-Scottsville Parent Boosters, Inc.

document, the corporation shall not carry on any other activities not permitted to be carried on (a) by any organization exempt from federal income tax under section 501 (c)(3) of the Internal Revenue Code, corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE VII BOARD OF DIRECTORS

Allen County Schools Parent Boosters, Inc. shall be governed by its board of directors as described in the Bylaws. The number of directors consulting the initial Board of Directors is seven (7), who are to serve as the initial directors until the first annual meeting, or until their successors are elected and qualified. The members of the Board of Directors, beyond the initial directors, shall be those individuals selected by the members in accordance with the Bylaws and are not limited in number by these Articles. The formula for determining the number of members comprising the Board of Directors is set forth in the Bylaws.

ARTICLE VIII DISTRIBUTION UPON DISSOLUTION

Upon the dissolution of the corporation, after paying or making provisions for the payment of all the legal liabilities of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine which are organized and operated exclusively for such purposes.

ARTICLE IX PERSONAL LIABILITY

No officer or director of this corporation shall be personally liable for the debts or obligations of Allen County Schools Parent Boosters, Inc. of any nature whatsoever, nor shall any of the property or assets of the officers or directors be subject to the payment of the debts or obligations of this corporation.


ARTICLE X APPOINTMENT OF REGISTERED AGENT
