**ARTICLES OF MERGER
 OF
 INFINITY STEEPLECHASE, L.L.C.
 WITH AND INTO
 VR STEEPLECHASE LIMITED PARTNERSHIP**

Pursuant to the provisions of KRS 275.360, the undersigned entities ("**Constituent Entities**") hereby adopt the following Articles of Merger for the purpose of merging Infinity Steeplechase, L.L.C., a Kentucky limited liability company, with and into VR Steeplechase Limited Partnership, a Delaware limited liability company, which shall be the surviving entity in the merger:

FIRST: The names and jurisdictions of organization of each Constituent Entity are:

<u>Name</u>	<u>Jurisdiction</u>
Infinity Steeplechase, L.L.C.	Kentucky
VR Steeplechase Limited Partnership	Delaware

SECOND: The name of the surviving business entity is VR Steeplechase Limited Partnership.

THIRD: The Constituent Entities do not desire for the merger cause any changes to the Certificate of Organization of the surviving entity.

FOURTH: A plan of merger was duly authorized and approved by each of the Constituent Entities in accordance with KRS 275.350 and corresponding Delaware law.

FIFTH: The Merger shall be effective upon the filing of these Articles of Merger with the Kentucky Secretary of State's office and a corresponding Certificate of Merger with the Delaware Secretary of State's office.

SIXTH: The surviving business entity (i) agrees that it may be served with process in the Commonwealth of Kentucky in any proceeding for enforcement of any obligation of any constituent business entity party to the merger that was organized under the laws of the Commonwealth of Kentucky, as well as for enforcement of any obligation of the surviving business entity arising from the merger; and (ii) appoints the Kentucky Secretary of State as its agent for service of process in any such proceeding. The address to which a copy of the process shall be mailed to the surviving business entity by the Kentucky Secretary of State is c/o Corporate Creations Network Inc., 101 North Seventh Street, Louisville, KY 40202.




