ARTICLES OF INCORPORATION -OF-

APOSTOLIC COMMUNION OF ANGLICAN CHURCHES, INC. COMMONWEALTH OF KENTUCKY NON-PROFIT CORPORATION: KRS 273.161

The undersigned incorporator, Archbishop++Darel E. Chase, PhD, OSP, executes these Articles of Incorporation for the purpose of forming and does hereby form a nonstock, nonprofit corporation under the laws of the Commonwealth of Kentucky, KRS 273.161 et seq., with all the rights privileges and immunities of a corporation organized for religious purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986, as amended (the "Code"), or it's successor provisions, in accordance with the following provisions.

ARTICLE I: NAME

The name of this corporation shall be:

APOSTOLIC COMMUNION OF ANGLICAN CHURCHES, INC.

ARTICLE II: PURPOSE

This organization is organized exclusively for religious, educational and charitable purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Specifically, this organization is organized for the following purposes:

(i) To support the continuation, maintenance, expansion, and activities of the Apostolic Communion of Anglican Churches, Inc. and to serve as the primary fund raising organization for Apostolic Communion of Anglican Churches, Inc.

(ii) To enhance access to capital resources, including a program to encourage philanthropic giving in furtherance of the joint mission of the Corporation and Apostolic Communion of Anglican Churches, Inc.

Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE VII: STATEMENT OF DISSOLUTION

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for public use. Any such assets not disposed of shall be disposed by the Court of Common Pleas of the county in which the principle office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
