ARTICLES OF ORGANIZATION

OF PROJECT RECOVERY LLC

Pursuant to Kentucky Revised Statutes (KRS) Chapter 275, the undersigned organizer hereby establishes Project Recovery Nonprofit LLC as a nonprofit limited liability company and submits the following Articles of Organization in the **Commonwealth Of Kentucky**:

Article 1 – Name

The name of this nonprofit limited liability company is Project Recovery LLC (the “LLC”).

Article 2 – Principal Office

The principal office of the LLC is:

2906 Dixie Hwy, Louisville, KY 40216

Article 3 – Registered Agent and Office

The registered agent for service of process is **A Vision For You Inc.**, whose registered office is located at:

1675 Story Ave, Louisville, KY 40206

Article 4 – Management Structure

This LLC shall be manager-managed in accordance with KRS § 275.025. The sole member of this LLC is A Vision For You Inc., a Kentucky nonprofit public charity. The managers shall be elected in accordance with the Operating Agreement of the company and shall have only the authority granted therein. Managers shall have no ownership interest in the LLC and shall serve at the discretion of the sole member.

Article 5 – Managers at the Time of Formation

The following individuals shall serve as the initial managers of the LLC:

Gregory Haynes – Manager (Business Address: 2906 Dixie Hwy, Louisville, KY 40216)

Johnathan Lucas Bennett – Manager (Business Address: 2906 Dixie Hwy, Louisville, KY 40216)

Evan Massey – Manager (Business Address: 2906 Dixie Hwy, Louisville, KY 40216)

Charles Moore – Manager (Business Address: 2906 Dixie Hwy, Louisville, KY 40216)

The managers shall have only those powers and responsibilities as defined in the Operating Agreement, and they shall act at the discretion of the sole member, A Vision For You Inc.

Article 6 – Organizer

The undersigned individual shall act as the Organizer of this LLC:

Article 7 – Purpose

The purpose of this LLC is to operate exclusively for charitable and nonprofit purposes within the meaning of Section 501©(3) of the Internal Revenue Code. The LLC shall provide recovery housing and supportive services for A Vision For You Inc., when such activities fall outside the scope of the parent organization’s bylaws.

Article 8 – Nonprofit Status

This LLC is formed as a nonprofit entity and shall not engage in any activities that jeopardize its tax-exempt status under Section 501©(3) of the Internal Revenue Code. No part of the LLC’s net earnings shall inure to the benefit of any private individual or entity.

Any revenue generation must align with its mission and be reinvested into its operations, expansion, and sustainability.

The LLC shall be subject to oversight by its sole member, ensuring adherence to nonprofit principles.

Article 9 – Operating Agreement

The operations and governance of this LLC shall be subject to a written Operating Agreement, which shall:

Define the rights, powers, and limitations of the sole member and managers.

Establish the election, removal, and authority of managers.

Outline financial, governance, and operational procedures.

Ensure compliance with nonprofit laws and regulations.

Article 10 – Limitations on Authority

1. Managerial Restrictions:

a. Managers shall not have the authority to take loans, sell assets, enter contracts, or bind the LLC in any significant financial or legal matter without the prior written consent of the sole member.

b. Managers shall have no right, title, or claim to any membership interest in the LLC.

2. Sole Member's Authority:

a. A Vision For You Inc. retains full ownership and control of the LLC and may amend the Operating Agreement to define additional governance measures as needed.

Article 11 – Dissolution

Upon dissolution of the LLC, all remaining assets shall be distributed exclusively to A Vision For You Inc. or another nonprofit organization qualifying under Section 501©(3) of the Internal Revenue Code.

Article 12 – Amendments


These Articles of Organization may be amended only with the approval of the sole member, A Vision For You Inc., and in accordance with KRS Chapter 275.

Article 13 – Indemnification

To the fullest extent permitted by Kentucky law, the LLC shall indemnify its member, managers, officers, and employees against liabilities arising from business operations, except in cases of fraud, willful misconduct, or gross negligence.
