**ARTICLES OF ORGANIZATION**

The undersigned, being the Member and Organizer of the Limited Liability Company hereby being formed under the Kentucky Limited Liability Company Act, does hereby adopt the following Articles of Organization for the Limited Liability Company:

**FIRST:** The name of the Limited Liability Company is:

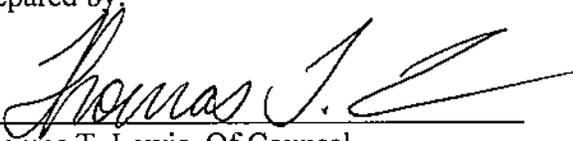

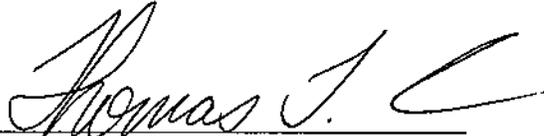
