The duration of the Corporation shall be perpetual.

The shareholders in the Corporation shall not be personally liable for the debts and obligations of the Corporation. To the extent permitted by KRS 271B.2-020(2)(d) the Corporation's director(s) shall not be personally liable for monetary damages for a breach of duties owed as a director.


