

ARTICLES OF ORGANIZATION

The undersigned hereby forms and organizes a limited liability company pursuant to the Kentucky Limited Liability Company Act and adopts the following Articles of Organization of such limited liability company:

ARTICLE I

The name of this limited liability company is C&C Real Estate Holdings, LLC (hereinafter, the "Company"). The purpose of the Company shall be to own real estate, to engage in all purposes related thereto, to engage in any other lawful purpose.

ARTICLE II

The effective date of these Articles of Organization shall be the date these Articles are filed with the Kentucky Secretary of State.

Except as otherwise provided by Kentucky law, no member, manager, agent, or employee of the Company shall be personally liable for the debts, obligations, or liabilities of the Company, whether arising in contract, tort, or otherwise, or for the acts or omissions of any other member, manager, agent, or employee of the Company.



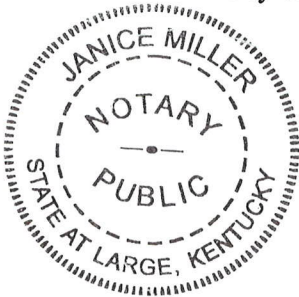
