**ARTICLES OF ORGANIZATION  
OF  
RISE N FIND, LLC**

The undersigned hereby organizes a Kentucky Limited Liability Company pursuant to the Kentucky Limited Liability Company Act (the "Act) and adopts the following Articles of Organization of such limited liability company:

**ARTICLE I**

**NAME OF LIMITED LIABILITY COMPANY**

The name of the limited liability company is Rise N Find, LLC (the "Company").

**ARTICLE II**

**INITIAL REGISTERED OFFICE AND INITIAL REGISTERED AGENT**

**LIMITATION OF LIABILITY**

Except otherwise provided by Kentucky law, no member, manager, agent or employee of the Company shall be liable for the debts, obligations, or liabilities of the Company, whether arising in contract, tort, or otherwise, or for the acts or omissions of any other member, manager, agent, or employee of the Company.


