ARTICLES OF INCORPORATION.

FIRST. The name of the corporation is The Granted Grace Foundation, Inc..

SECOND. Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: To mentor and provide prom dresses to underprivileged girls.
