

# **ARTICLES OF ORGANIZATION OF CNH OPERATING, LLC**

For the purpose of forming a limited liability company in Kentucky pursuant to KRS Chapter 275, the undersigned organizer hereby submits the following Articles of Organization to the Kentucky Secretary of State for filing:

## **ARTICLE I**

### **Name**

The name of the limited liability company shall be **CNH OPERATING, LLC** (hereinafter sometimes referred to as the "Company").

## **ARTICLE II**

### **Initial Registered Office and Initial Registered Agent**

The initial registered office of the Company shall be located at 1481 Craft Creek Road, Salyersville, Kentucky, 41465, and the initial registered agent at such office shall be 1481 Craft Creek Road, Salyersville, Kentucky 41465

## **ARTICLE III**

### **Initial Principal Office**

## **ARTICLE IV**

### **Statement of Members**

At the time of the filing of these Articles of Organization, the Company has One (1) member. Their name is William Craig Hart.

## **ARTICLE V**

### **Statement of Management**

The Company is to be managed by its member, William Craig Hart, who shall have one hundred percent (100%) ownership in the Company.

**ARTICLE VI**  
Purpose and Powers

The purpose of the Company is to engage in any and all legal lawful business purposes and to engage in other general business purposes. The Company has all of the powers provided by law, and the Company may use those powers for any lawful purpose.

**ARTICLE VII**  
Dissolution

The duration of the Company shall be perpetual, until its dissolution in accordance with the Kentucky Limited Liability Company Act, KRS Chapter 275.

**ARTICLE VIII**  
Indemnification


