
#### ARTICLES OF ORGANIZATION OF DOUBLE B MULCHING, LLC

# **ARTICLE I**

# NAME OF LIMITED LIABILITY COMPANY

#### LIMITATION OF LIABILITY

Except otherwise provided by Kentucky law, no member, manager, agent or employee of the Company shall be liable for the debts, obligations, or liabilities of the Company, whether arising in contract, tort, or otherwise, or for the acts or omissions of any other member, manager, agent, or employee of the Company.
