**ARTICLES OF ORGANIZATION  
OF  
S & B REALTY GROUP, LLC**

**SECTION 1 INTRODUCTION AND PRELIMINARY STATEMENTS**

The undersigned Organizer desires to form a limited liability company under the Laws of the Commonwealth of Kentucky by delivering these Articles of Organization in duplicate to the Secretary of State of the Commonwealth of Kentucky, in accordance with Kentucky Limited Liability Company Act (the *Act*).

**SECTION 2 NAME**

The name of the limited liability company is S & B Realty Group, LLC, a Kentucky limited liability company (*Company*).

**SECTION 3 DURATION**

The Company will perpetually exist from the filing date of these Articles of Organization with the Secretary of State of the Commonwealth of Kentucky, unless dissolved according to law.

**SECTION 4 COMPANY'S PURPOSE**

The Company's purpose is to engage in any lawful act or activity for which limited liability companies may be formed under the Act and all activities necessary or incidental to that purpose. The Company has all the powers necessary or convenient to carry out its purposes, including the powers granted by the Act.

**SECTION 5 COMPANY'S PRINCIPAL OFFICE AND LOCATION OF RECORDS**

The street address of the principal office in the United States where the Company maintains its records is 2008 South Woodland Drive, Radcliff, Kentucky 40160.

**SECTION 6 REGISTERED AGENT AND REGISTERED OFFICE**

The Company's initial Registered Agent is Hon. J. Brannon Dupree, and the Company's initial registered office is located at 328 North Mulberry Street, Elizabethtown, Kentucky 42701.

## SECTION 7 REGISTERED AGENT CONSENT

I, Hon. J. Brannon Dupree, a natural person and resident of Kentucky, accept the appointment as Registered Agent of S & B Realty Group, LLC, a Kentucky limited liability company. I understand that my responsibilities as Registered Agent are to receive service of process, notices, and demands; to forward mail; and to notify the Secretary of State immediately if I resign or if the registered office address changes from the addresses stated above.

This Operating Agreement may be amended from time to time according to its provisions.

## SECTION 9 MANAGEMENT


