**Articles of Incorporation of Tony Lundy Ministries, Inc.**

The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Kentucky, do hereby certify:

**ONE:** The name of the Corporation shall be Tony Lundy Ministries, Inc.

**TWO:** The place in this state where the principal office of the Corporation is to be located is 580 Rice Rd, Morehead, KY 40351, Rowan County.

**THREE:** Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**FOUR:** The names and addresses of the persons who are the initial directors of the corporation are as follows:

The business affairs of the corporation shall be governed by a board of directors. The three (3) members of the initial board of directors shall serve until the first annual election of directors and until their successors are elected and qualify. A director may be removed from office by vote of the majority of the board of directors, with or without cause.

**FIVE:** No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**SIX:** Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

**SEVEN:** Registered Office and Registered Agent

The street address of the initial registered office of the corporation is 580 Rice Rd. Morehead, KY 40351. The name of the registered agent is Antony Lundy II.


