**ARTICLES OF ORGANIZATION
OF
DREAMS COME TRUE, LLC**

(A Kentucky Limited Liability Company)

To the Secretary of State, Commonwealth of Kentucky:

The undersigned, natural person, age eighteen or older, as organizer of a Limited Liability Company under the Kentucky Limited Liability Company Act, does hereby adopt the following Articles of Organization for said Limited Liability Company (hereinafter referred to as "the company").
