

### ARTICLES OF INCORPORATION

<u>OF</u>

### TRIANGLE INSURANCE AGENCY, INCORPORATED

WE, the undersigned, in order to form a corporation for the purposes hereinafter stated, under and pursuant to the provisions of the Oklahoma Insurance Code and the Oklahoma Business Corporation Act, do hereby certify, as follows:

#### ARTICLE I Name

The name of the corporation is:

### TRIANGLE INSURANCE AGENCY, INCORPORATED

## ARTICLE II Place of Business

The principal office of the corporation is to be located at 2300 North 10th, Enid, Oklahoma. The name of its registered agent is Willis DeSpain, whose address is 2300 North 10th, Enid, Oklahoma.

## ARTICLE III Nature of Business

The nature of the business of the corporation, and the objects and purposes proposed to be transacted, promoted, or carried on by it, are, as follows, to-wit:

To solicit, negotiate, effectuate, and sell all kinds and types of insurance, and, generally, to conduct an insurance agency in all its branches.

# ARTICLE IV Authorized Capital Stock

#### ARTICLE V Stated Capital

The amount of capital stock with which the corporation will commence business is the sum of One Thousand Dollars (\$1000.00), being One Hundred (100) shares of the Common Capital Stock of the corporation, of the par value of Ten (\$10.00) Dollars each.

#### ARTICLE VI Subscribers

The names and places of residence of each of the original subscribers to the capital stock are, as follows:

## ARTICLE VII Duration

The corporation shall exist for a period of fifty (50) years.

## ARTICLE VIII Liability

The private property of the stockholders shall not be subject to the payment of corporate debts to any extent whatever.

### ARTICLE IX Directors

The number of directors of the corporation shall be not less than three (3) and shall be fixed from time to time by the By-Laws, and the number may be altered as therein provided. In case of any increase in the number of directors, the additional directors shall be elected as provided in the By-Laws, by the directors or by the stockholders at an annual or a special meeting. In case of any vacancy in the Board of Directors, the remaining directors by affirmative vote of a majority thereof, may elect a successor to hold office for the unexpired portion of the term of the director whose place is vacant, and until his successor shall be duly elected and qualified.

The Board of Directors shall have all the powers conferred by law.

## ARTICLE X Meetings

Both the stockholders and the directors of the corporation may hold their meetings and the corporation may have an office or offices in such place or places either in or outside of the State of Oklahoma as the By-Laws may provide; and the corporation may keep its books outside of the State of Oklahoma, except as otherwise provided by law.

## ARTICLE XI Amendments

The corporation reserves the right to amend, alter, change, or repeal any provision contained in this Certificate of Incorporation in the manner, now or hereafter prescribed by statute; and all rights conferred on stockholders herein are granted subject to this reservation.
