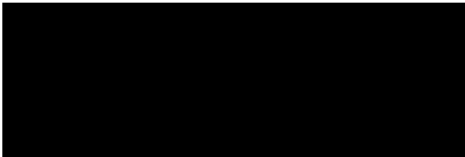

Based upon the Department of Revenue records and the information submitted, **GEORGETOWN-SCOTT COUNTY MUSEUM, INC.** is exempt from filing a Kentucky Corporation Income Tax Return pursuant to KRS 141.040, KRS 141.0401 and KRS 136.070.
