

**ARTICLES OF CORPORATION OF
ONE OF EIGHT, INC.**

The undersigned, acting as incorporator of a corporation for profit under the Kentucky Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE ONE: The name of the corporation is One of Eight, Inc.

ARTICLE TWO: The duration of the corporation is perpetual.

ARTICLE THREE: The purpose for which the corporation is organized is to engage in any activity within the purposes for which corporations may be organized under the Kentucky Business Corporation Act.

ARTICLE FOUR: The aggregate number of shares which the corporation shall have authority to issue shall be 10,000, all of which stock shall be common with no par value per share, and all of which stock shall be voting stock. Such shares shall be without distinction as to designations, preferences, limitations or relative rights and priorities.

ARTICLE FIVE: Provisions for the regulation of the internal affairs of the corporation shall be set forth in the by-laws of the corporation as duly adopted or from time to time altered, amended or repealed by the Board of Directors subject to repeal or change by action of the shareholders.

ARTICLE SIX: The address of the initial principal office of the corporation is 19366 Louisville Rd, Park City KY 42160.

ARTICLE SEVEN: The name of the corporation's initial registered agent and address is Gerald Poppy, 19366 Louisville, Park City, KY 42160.

ARTICLE EIGHT: The number of directors constituting the initial Board of Directors shall be 1 and the names and address of the persons who are to serve as directors until the first shareholder's meeting or until their successor is elected and shall qualify are:

ARTICLE NINE: The name and address of the sole incorporator is Gerald Poppy, 19366 Louisville, Park City, KY 42160.

ARTICLE TEN: The private property of the stockholders shall not be subject to the payment of corporate debts or liabilities, nor shall corporation property be subject to the payment of stockholder debts or liabilities.
