The undersigned, John C. Miller, executes these Articles of Organization for the purpose of forming and does hereby form a professional limited liability company under the laws of the Commonwealth of Kentucky in accordance with the following provisions.

**ARTICLE 1****Name**

The name of the professional limited liability company is "Trigg & Bullitt, PLLC".

**ARTICLE 2****Purposes and Powers**
