The association did not have governing principles providing time or method for dissolution upon approval by the members. All activities have been wound up and were terminated pursuant to rules outlined in KRS 273A.130.

We have enclosed Meeting Minutes of the organization where a unanimous vote was received to pursue dissolution. All debts were paid to outside third parties using remaining organizational funds with funds provided to the organization by its members. There were no assets in the company to be distributed after payment of the debts. The checking account was closed.

## Meeting Minutes – November 5, 2022

Cyndi White called the meeting to order at 1:00 pm.

Cyndi White presented the auto payment charges that were being debited from the bank account. These charges were subscription renewals for online services that were no longer being used. And the current members had no access to cancel these automatic subscription renewals. To help pay the organization's liabilities, members of the association loaned their personal funds.

Cyndi White also presented the previous 2 years' sales & use tax returns of near zero sales since 2020.

- Year 2021 only \$1.18 sales & use tax was due.
- Year 2022 zero sales & use tax was due.

The members of the association voted unanimously to:

- Close the bank account which would stop the auto renewals.
- Reimburse loans to the lending members.
- Dissolve the Unincorporated Non-Profit Association, Kentucky Music Productions Ltd, effective 12/31/2022.
- Notify Kentucky Department of Revenue of the dissolution [via Form 10A104]
