# ARTICLES OF ORGANIZATION OF GIBSON LOGGING ENTERPRISES, LLC

The undersigned, pursuant to Chapter 12 of Title 13.1 of the Code of Virginia, states as follows:

- 1. The name of the limited liability company is Gibson Logging Enterprises, LLC.
