**ARTICLES OF INCORPORATION**

**Article I:** The name of the corporation is Joshua's Choice Ministries.

**Article II:** In accordance with Jesus' teachings, the mission of the non-profit corporation is to reach out to hurting people with the love of God and then teach them how to return that love and how to live joyful, fulfilling, responsible lives despite their troubles.

**Article III:** The name of the registered agent is Jennifer M. Cox whose address is 3300 Old Sligo Road, La Grange, Kentucky 40031.

**Article IV:** The place in this state where the principal office of the non-profit corporation is to be located is 3300 Old Sligo Rd., La Grange, Kentucky 40031.

**Article V:** The non-profit corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.


**Article VII:** No part of the net earnings of the non-profit corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the corporation's purpose. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this non-profit corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this non-profit corporation.

**Article VIII:** Upon the dissolution of the non-profit corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

**Article IX:** Jennifer M. Cox is the Incorporator of this non-profit corporation, Joshua's Choice Ministries. Her address is 3300 Old Sligo Rd., La Grange, KY 40031.

**Article X:** These Articles shall become effective upon the filing of this document with the Kentucky Secretary of State's Office.
