Based upon the Department of Revenue records and the information submitted, **FRANKLIN SOUSLEY POST NO. 1834, VETERANS OF FOREIGN WARS OF THE UNITED STATES, INCORPORATED** is exempt from filing a Kentucky Corporation Income Tax Return pursuant to KRS 141.040, KRS 141.0401 and KRS 136.070.
