

**ARTICLES OF ORGANIZATION**  
**OF**

**A LIMITED LIABILITY COMPANY**

The undersigned does hereby form a Limited Liability Company, (hereafter, Company) under and by virtue of the Kentucky Limited Liability Company Act, KRS Chapter 275, and adopts the following Articles of Organization:

**ARTICLE I**

**NAME**

The name of the Company is Buckingham Golf LLC.

**ARTICLE II**

**PURPOSES**

The Company is organized and operated for any and all other lawful purposes for which companies may be organized under the Kentucky Limited Liability Company Act.

The Company has one (1) Member, namely Tyler D. Buckingham. The rights and qualifications of a member or future members of the Company shall be as set forth in the Operating Agreement for the Company.

## **ARTICLE VI**

### **MANAGEMENT**

The Company is to be managed by its Member.

## **ARTICLE VII**

### **DISSOLUTION**



Provided, however, that the remaining Members may vote to continue the existence of the Company and its business within the time period provided by KRS 275.280, or its successor, or within a specified time period set forth in the Operating Agreement.

The private property of the Members shall not be subject to the debts of the Company. The Members, agents and employees of the Company shall not be personally liable on the Company's obligations or liabilities.


