# FILING INSTRUCTIONS STATEMENT OF CHANGE OF PRINCIPAL OFFICE ADDRESS

### NAME

Use the exact name of the business entity as registered on file with the Office of the Secretary of State.

### **PRINCIPAL OFFICE ADDRESS**

The principal office is the office (in or out of this state) so designated in writing with the Office of the Secretary of State where the principal designated office of the business entity is located. This address is where all correspondence from the Office of the Secretary of State (See Document Delivery) will be mailed.

### **DOCUMENT DELIVERY**

A file stamped postcard will be sent to the principal office address. If the applicant wishes for the document to be sent to an alternate address other than the principal office, a request must be submitted in writing affirming that request. Alternate address requests must be submitted with each document filed with the Office of the Secretary of State.

# WHO MAY SIGN

The document must be signed by an officer, chairman of the board, member, manager, partner or trustee.

# **NUMBER OF COPIES**

When filing online, no copies are required. If filing via mail or in person, one exact copy of the document with the filing fee must be submitted to the address below. To make a copy of the filing for delivery to the local county clerk's office, visit www.sos.ky.gov and print a copy from the organization search tool.

# FILING FEE

The filing fee for changing a principal office is \$10.00. Checks should be made payable to the "Kentucky State Treasurer."
