ARTICLES OF INCORPORATION

OF

INNOVATIVE CAPITAL, INC.

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, Douglas K Lackey, hereby forms a corporation under the laws of the Commonwealth of Kentucky.

ARTICLE I

The Corporation hereby proposed and organized shall be named, designed and known as

INNOVATIVE CAPITAL, INC.

by which name it may contract, be contracted with, sue and be sued, adopt a corporate seal and do any and all other lawful things necessary and proper in the conduct of its business.

ARTICLE II

The nature and purpose of this Corporation shall be the transaction of any and all lawful business for which corporations may be incorporated under the laws of the Statutes of the Commonwealth of Kentucky.

ARTICLE III

The duration of the Corporation shall be perpetual unless sooner dissolved by vote of the majority of the owners of the capital stock,

ARTICLE IV


ARTICLE IX
