Articles of Dissolution

My name is Lissa Hoops and I created Willoughby's, LLC in November 2023. I have never owned a "Willoughbts LLC. I filed my Willoughby's LLC with the KY SOS in December 2023 and around the same time, hired an accountant by the name of Robert F. Kuphal, CPA 3520 New Hartford Rd, Suite 301 Owensboro, KY 42303 phone- 270-684-5158 to help me with payroll and tax filings. I had no idea at the time how incompetent Mr. Kuphal is. He took it upon himself to also file my Willoughby's LLC with the SOS, even though I already had and without my permission, in addition, he filed with the incorrect spelling of Willoughb"t"s LLC. This has created a nightmare for me ever since because it is now showing that I have an additional LLC and I do not. Back in early 2024, I addressed Mr. Kuphal about this and even paid him the \$200 (since he refused to correct his mistake himself) he said it would cost me to dissolve the fake business with the SOS. I recently learned from a phone call with the SOS that he did not dissolve this LLC but that it was in an inactive standing and I was then advised by the SOS to reinstate the LLC and file the annual report for an additional \$115, which I did on 11/21/2024. I was further advised by the SOS that after reinstating, to wait a bit and then file for the dissolution of this fake LLC! This is now costing me an additional \$40, which I am doing here and now. I just really want this phantom LLC to be disassociated from me and my actual business. I am now out almost \$1000 or something that is not mine, nor my doing. How can Mr. Kuphal be held accountable? Please dissolve this ASAP.
