ARTICLES OF ORGANIZATION

PROFIT LIMITED LIABILITY COMPANY

ARTICLE 1: Name

The name of the limited liability company is **Business Solutions Group, LLC**.

ARTICLE 2: Registered Office and Registered Agent

The foregoing statement of purposes shall be construed both as objects and powers, and the enumeration of specific purposes shall not be considered to limit or restrict in any manner the general powers of the limited liability company as set forth in the laws of the state of Kentucky.

ARTICLE 8: Management

This Limited Liability Company shall be managed by its members. Each member shall have equal management rights, and decisions regarding the ordinary course of business and other major decisions shall be made by a vote of the members.

In the absence of a designation of managers by the members, each member shall have the authority to act on behalf of the LLC in all matters.
