ARTICLES OF ORGANIZATION

OF

RIVER BEND HUNTING CLUB LLC

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, desiring to form a limited liability company, does hereby adopt the following Articles of Organization for and on behalf of such limited liability company.

ARTICLE I

<u>Name</u>

The name of the limited liability company shall be River Bend Hunting Club LLC.
