# Articles of Incorporation Of Friends of the Holt Home, Inc.

For the purposes of forming a nonprofit corporation in Kentucky pursuant to KRS 14A and KRS 273, the undersigned incorporator hereby submits the following Articles of Incorporation to the Secretary of State for filing:

# Article I

The name of the corporation is Friends of the Holt Home, Inc.

# **Article II**

The purpose for which this corporation is organized is to obtain funds through grants, fundraising activities and donations for the oversight of restoration and operation of the Judge Joseph Holt Home and cemetery and for the administration of educational training programs, and public awareness campaigns to preserve and honor the legacy of Judge Joseph Holt, and for any lawful purpose set forth in KRS 273.167.

Said corporation is organized exclusively for charitable, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, trustees, officers, or private persons, except that the corporation shall be authorized and empowered to pay any reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by any corporation exempt from federal tax under sections 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by any corporation, contributions which are deductible under section 170(c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which

the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

# **Article III**

The name of the registered agent is Stephen G. Hopkins, Esq., and the street address of the corporation's initial registered office in Kentucky is 83 Ballpark Road, Hardinsburg, Kentucky 40143.
