Articles of Incorporation of Heralds of Good News Mary Queen of Apostles Province, Inc.

The undersigned incorporate executes these articles of incorporation for the purpose of forming and does form a nonprofit corporation under the laws of the Commonwealth of Kentucky, in accordance with the following provisions.

ARTICLE I

Name

The name of the corporation is **HERALDS OF GOOD NEWS MARY QUEEN OF APOSTLES PROVINCE, INC.**

ARTICLE II

Purposes and Powers

- (A) The corporation is organized and operated exclusively for religious purposes. In carrying out its corporate purposes, the corporation shall have all the powers allowed corporations under Chapter 273 of the Kentucky Revised Statutes.
- (B) In furtherance of the general purposes in paragraph (A), the particular purposes of the corporation are: various social services, including education of children; support of missionaries of Heralds of Good News Mary Queen of Apostles Province, Inc. working in third world countries such as India, Papua New Guinea, Tanzania, Kenya, Uganda, Guatemala; and education of seminarians or Priest Students.

ARTICLE III
