ARTICLES OF INCORPORATION

of

KNOW ALL MEN BY THESE PRESENTS:

The undersigned, being a natural person of the age of eighteen (18) years, or more, desiring to form a corporation, for profit, under KRS 271B, does hereby certify:

1. The name of the Corporation shall be:

JAKE FASHINGBAUER, INC.

2. The duration of said Corporation shall be perpetual.

3. The purposes for which it is formed are: The transaction of any or all lawful business for which corporations may be incorporated under KRS 271B.3.

4. The aggregate number of shares which the Corporation shall have the authority to issue shall be One Thousand (1,000); such shares consisting of one class only; all shares to be No Par Value shares; and further, said shares shall be issued in such a manner as to conform with an IRS Code 1244 Election.

5. Shareholders' preemptive rights shall be consistent with KRS 271B.6-300.

6. The regulation of internal affairs of the Corporation, including any provision restricting transfer of shares, shall be exclusively governed by the By-Laws of the Corporation.
