

**ARTICLES OF ORGANIZATION OF
VEGETABLE MAN'S COUNTRY MARKET, LLC**

KIRK JONES, as ORGANIZER, desiring to form a limited liability company under Chapter 275 of the Kentucky Revised Statutes, hereby states as follows:

ARTICLE I

NAME. The company name is VEGETABLE MAN'S COUNTRY MARKET, LLC (hereinafter referred to as the "Company").

ARTICLE II

DURATION. The duration of the Company shall be perpetual.

ARTICLE III

REGISTERED ADDRESS and REGISTERED AGENT. The registered office address of the Company is 136 Henry St. Junction City, KY 40440, the name of the initial registered agent at that address is KIRK JONES.

ARTICLE IV

PRINCIPAL OFFICE. The principal office and mailing address of the Company is 136 Henry St. Junction City, KY 40440.

MANAGEMENT. The company shall be managed by its MEMBER(S), the Company shall initially be a single member LLC with its sole member being KIRK JONES.


ARTICLE VI

PURPOSE. The purpose of the company is to conduct any business permitted by law.

Except as otherwise provided by Kentucky law, no member, manager, agent, or employee of the limited liability company shall be personally liable for the debts, obligations, or liabilities of the company, whether arising in contract, tort, or otherwise, or for the acts or omissions of any other member, manager, agent, or employee of the company.


