ARTICLES OF ORGANIZATION

of

A KENTUCKY

LIMITED LIABILITY COMPANY

The undersigned, Elizabeth K. True, executes these Articles of Organization for the purpose of forming and does hereby form a limited liability company under the laws of the Commonwealth of Kentucky in accordance with the following provisions.
