ARTICLES OF ORGANIZATION

OF

TRIPLE TCH LLC

A Limited Liability Company

The undersigned, herein designated as the initial registered agent for the limited liability company organized hereby and pursuant to and under Kentucky Revised Statutes Chapter 275 (herein "the Act"), adopts the following Articles of Organization for such limited liability company:

The term of existence of TRIPLE TCH LLC is perpetual.


ARTICLE VII


