

ARTICLES OF ORGANIZATION
OF
B&C PROPERTIES OF LOUISVILLE, LLC.

KNOW ALL MEN BY THESE PRESENTS that the undersigned hereby proposes to form a limited liability company pursuant to the Kentucky Limited Liability Company Act, Chapter 275 of the Kentucky Revised Statutes and files therefore the following Articles of Organization:

ARTICLE I

The name of the company shall be B&C Properties of Louisville, LLC., hereinafter "the company".

ARTICLE II

The street address of the Company's initial registered office and the name of its initial registered agent at that office are Vincent F. Heuser, Jr., 3600 Goldsmith Lane, Louisville, KY 40220.

ARTICLE III

The mailing address of the company's principal office is 611 Oak Branch Road, Louisville, KY 40245.

ARTICLE IV

The company is to be manager managed. Initially there shall be two managers, Catherine A. Sweeney and William D. Perry, either of whom may act independently of the other. Upon the death, disability, resignation or other inability to act of either of them, the replacement co-manager shall be:

1. Catherine A. Sweeney shall be replaced by Deryl L. Sweeney
2. William D. Perry shall be replaced by Bryan Perry

The successor member from each of the initial managers member shall serve as co-Managers, but shall be required to act jointly with the other co-Manager.

ARTICLE V

The duration of the Company is perpetual.

ARTICLE VI

To the fullest extent permitted by law, the Company shall indemnify each member, manager or officer of the Company against expenses (including attorneys' fees), judgments, taxes, penalties, fines (including any excise tax assessed with respect to an employee benefit plan) and amounts paid in settlement (collectively "Liability"), incurred by such member, manager or officer in connection with defending any threatened, pending, or completed action, suit, or proceeding (whether civil, criminal, administrative, or investigative) to which such member, manager or officer is, or is threatened to be made, a party because such member, manager or officer is or was a member, manager or officer of the Company. The indemnification against Liability and advancement of expenses granted pursuant to this Article shall not be deemed exclusive of any other rights to which those seeking indemnification or advancement may be entitled. The Company may purchase and maintain insurance on behalf of an individual who is or was a member, manager, officer, employee or agent of the Company.

ARTICLE VII

To the fullest extent permitted by law a manager or officer of the Company shall not be personally liable to the Company or its members for monetary damages for breach of the manager or officer's duties as a manager or officer.

ARTICLE VIII


The purposes for which the Company is organized include the transaction of all lawful business in which Kentucky limited liability companies are permitted to be engaged.

The name and mailing address of the organizer is Vincent F. Heuser, Jr., 3600 Goldsmith Lane, Louisville, Kentucky 40220.


